Purpose

The purpose of this PM is to transmit your Area Plan Contract Amendment #2 and revised Budget Display for Fiscal Year (FY) 2012-13. This contract amendment includes current year reductions due to the implementation of federal sequestration and Area Agencies on Aging's (AAA) approved funding transfer requests.

Federal Fiscal Year 2013 Sequestration Reduction The California Department of Aging (CDA) has received estimated reductions for Federal Fiscal Year (FFY) 2013 (October 2012-September 2013) due to federal sequestration. Because of the federal application of national minimum funding requirements and hold harmless requirements, cuts for the State of California ranged from 4.3 percent to 8.1 percent for federal Older Americans Act Title III, VII, and Nutrition Services Incentive Programs from FFY 2012 levels. In total, approximately \$7.5 million in federal local assistance funding was cut for FFY 2013.

Due to the late federal implementation of these reductions, all FFY 2013 savings must be achieved by September 2013. To calculate the amount of the reduction which applies to this State Fiscal Year (SFY) 2012/13, CDA has assumed a May 2013 implementation date and spread the reduction evenly across the remaining five months of FFY 2013 (May 2013-September 2013). The first two months of this reduction were applied to SFY 2012/13, and the remaining three months of the reduction will be applied in the contracts for SFY 2013/14.
