This Program Memo (PM) revises your Amendment #2 budget display for State Fiscal Year (FY) 2009-10 to reflect additional administration.

The baseline funding increase of \$6,607,130 in Amendment #2 did not include a ten percent allocation of the baseline funds for Local Assistance administration from the \$6.6 million. The attached revised budget display reflects a ten percent allocation for Local Assistance administration. Total funding by fund source and by Planning and Service Area remains unchanged from the figures displayed in Amendment #2.

Please replace the budget display previously sent with Amendment #2 with the budget display provided here. If you have already returned your contract amendment to the California Department of Aging (CDA), you will need to submit a revised budget that reflects the changes made on the new budget display attached.
