Dear Community-Based Adult Services (CBAS) Providers,

The State of California implemented the California Electronic Visit Verification (CalEVV) system for Personal Care Services (PCS) on January 1, 2022, and Home Health Care Services (HHCS) on January 1, 2023, in accordance with the federally mandated requirements of the 21st Century Cures Act.

The CalAIM 1115 Waiver requires the state to demonstrate compliance with the Electronic Visit Verification System (EVV) requirements for the provision of in-home PCS and HHCS to CBAS beneficiaries utilizing the CBAS Emergency Remote Services (ERS) benefit.

Effective March 23, 2023, the CalEVV system will begin supporting the California Department of Aging (CDA) CBAS and CBAS providers to ensure compliance with CBAS ERS EVV requirements.

# **CBAS Services Subject to EVV**

For CBAS providers, the following CBAS ERS benefits provided in the home are subject to EVV requirements:

- <u>Professional nursing services</u> (HHCS)
- <u>Personal care services</u> Activities of Daily Living and Instrumental Activities of Daily Living (PCS)
- <u>Therapeutic Activities</u> Physical Therapy and Occupational Therapy Maintenance Program (PCS)
- <u>Meal</u> If prepared in the home (PCS)
- <u>Restorative physical therapy</u> (HHCS)
- <u>Restorative occupational therapy</u> (HHCS)
- <u>Speech therapy</u> (HHCS)

When these services are provided, CBAS centers are required to submit the following HCPCS procedure codes on their claim. (For more details see the Medi-Cal Provider Manual at <u>Community-Based Adult Services (CBAS): Billing Codes and Reimbursement Rates (community cd) (ca.gov)</u>:

- S5136 CBAS-ERS PCS in the home; per diem
- Q5001 CBAS-ERS HHCS in the home; per diem



### The Cures Act and Data Collection

The Cures Act was enacted in 2016 and directs states to require the use of an EVV system for Medicaid-provided PCS and HHCS. The Cures Act requires that EVV systems electronically capture six data elements for every PCS or HHCS service that is provided in the home:

- 1. Type of service performed
- 2. Individual receiving the service
- 3. Date of the service
- 4. Location of service delivery
- 5. Individual providing the service
- 6. Time the service begins and ends

All services provided in the home that are identified as PCS or HHCS must have an EVV visit record in the CalEVV system or in a chosen Alternate EVV vendor system. The new EVV requirements will not change where and how these services are delivered.

#### **CBAS** Providers

CBAS providers are expected to be registered in CalEVV and begin submitting visit data electronically, either through the state-provided CalEVV system or a chosen Alternate EVV system starting March 23, 2023.

The state-provided CalEVV system is free to providers and is used to electronically capture the six EVV data elements mentioned above via a mobile app or telephone. Providers that have an existing electronic medical records or care management information system that provides EVV functionality may use that system as long as it meets EVV requirements, and their software vendor can integrate their system with the state's EVV aggregator and send compliant EVV data to the state.

If you have not yet registered in the CalEVV system, you will need to register and choose either the CalEVV state-provided system (free) or an alternate EVV vendor system. See the Provider Self-Registration instructions below.

If you have already registered or register prior to the go live date for CBAS in CalEVV, you will need to subsequently add the CBAS Provider ID and jurisdictional associations in Provider ID Maintenance in the CalEVV portal or aggregator.

#### **Managed Care Plans**

Managed Care Plans who are the payers for CBAS are required to ensure their contracted providers comply with EVV requirements. This includes ensuring all providers register for CalEVV and begin submitting visit data electronically, either through the state-provided CalEVV system (free) or a chosen Alternate EVV system starting March 23, 2023. Managed Care Plans can monitor provider compliance using the state-provided CalEVV aggregator and/or business intelligence tool.

# **CalEVV State Provided System Users**

If intending to use the CalEVV state-provided EVV system (free), complete self-registration using the link above and complete the required CalEVV Administrator Training.

- Instructions will be emailed upon completing self-registration which explain how to register for and complete the required administrator training. This training takes approximately 1 hour.
- Upon completion of training, you will receive your CalEVV credentials and a link to the CalEVV portal.
- Once you log into the CalEVV portal, you will need to add CBAS participants, employees, and services prior to recording visits. You can also update your provider IDs via the portal to associate your services with all applicable payers (e.g., Managed Care Plans and DHCS for Fee-For-Service participants).
- At this time, you will also provide training to your office staff and staff providing ERS PCS and HHCS in the home, using the webinars and recorded videos that you can access from the Sandata On-Demand training website. You'll need to log into the On-Demand website using your CalEVV credentials to access all applicable training.

# Alternate EVV System Users

If intending to use an Alternate EVV vendor system, you still need to complete self-registration using the link above and complete the required AltEVV Administrator Training.



- Be sure to clearly identify that you will be using an alternate EVV Vendor and software product when you self-register with CalEVV.
- Reach out to your alternate EVV software vendor and follow up as needed to ensure your vendor successfully completes testing with Sandata Technologies and becomes certified to send EVV data to the CalEVV aggregator.
- Complete the AltEVV aggregator administrator training using the link you will receive from the California Alternate EVV customer support team.

#### Services Excluded from EVV Requirements

The following services are **not subject to EVV requirements**:

- HHCS or PCS that do not require an in-home visit.
- HHCS or PCS provided in congregate residential settings where 24-hour service is available.
- HHCS or PCS rendered by live-in caregiver<sup>1</sup>.
- Any services rendered through the Program of All-Inclusive Care for the Elderly.
- HHCS or PCS provided to inpatients or residents of a hospital or nursing facility, including skilled nursing facility or residence of nursing facility, intermediate care facility for individuals with intellectual disabilities, or an institution for mental diseases.

<sup>&</sup>lt;sup>1</sup> A "Live-in Caregiver" is a caregiver who regularly remains in the recipient's home for more than 24 hours at a time and provides any of the authorized personal care services and home health care services. If a caregiver provides services to other recipients with whom they do not live, per the definition above, would need to register for EVV.
