

LSC Codes Cross Walk to ACL SPR Case Types Guide

ACL SPR data case types align with Older Americans Act priority areas, and as a result, do not align exactly with LSC data codes. In addition, some ACL case types do not have corresponding LSC data codes. Therefore, ACL recommends that legal assistance providers determine the case type using the definitions ACL has established (available in the “Legal Assistance SPR Guidebook”). However, this document provides guidance on how LSC case types and data codes may relate to SPR data case types.

<p>Income</p>	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Income Maintenance” codes 71 (TANF), 72 (Social Security (Not SSDI)), 74 (SSDI), 75 (SSI), 76 (Unemployment Compensation), 77 (Veterans Benefits), 78 (State and Local Income Maintenance), and 79 (Other Income Maintenance) • Does <u>not</u> include code 73 (Food Stamps)
<p>Health care</p>	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Health” codes 51 (Medicaid), 52 (Medicare), 53 (Government Children’s Health Insurance Programs), 55 (Private Health Insurance), 57 (State and Local Health), and 59 (Other Health) • Does <u>not</u> include code 54 (Home and Community Based Care) or 56 (Long Term Health Care Facilities)
<p>Long-term care</p>	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Health” codes 54 (Home and Community Based Care) and 56 (Long Term Health Care Facilities)
<p>Nutrition</p>	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Income Maintenance” code 73 (Food Stamps)

Housing	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Housing” codes 61 (Federally Subsidized Housing), 62 (Homeownership/Real Property (Not Foreclosure), 63 (Private Landlord/Tenant), 64 (Public Housing), 65 (Mobile Homes), 66 (Housing Discrimination), 67 (Mortgage Foreclosures (Not Predatory Lending/Practices)), 68 (Mortgage Predatory Lending/Practices), and 69 (Other Housing)
Utilities	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Consumer/Finance” code 07 (Public Utilities) or 09 (Other Consumer/Finance)
Abuse/Neglect	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Family” code 37 (Domestic Abuse)
Defense of Guardianship or Protective Services	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Miscellaneous” code 96 (Advance Directives/Powers of Attorney)
Age Discrimination	<p>May align with the following LSC legal problem categories and codes:</p> <ul style="list-style-type: none"> • “Individual Rights” codes 85 (Civil Rights) or 89 (Other Individual Rights) • “Employment” codes 21 (Employment Discrimination) or 25 (Employee Rights) • “Housing” codes 66 (Housing Discrimination) or 69 (Other Housing)
