WE WILL TALK ABOUT THE COVID UPDATES, STATE BUDGET

AND FEDERAL STIMULUS, OLDER CALIFORNIA PROGRAMS, LONG

TERM CARE OMBUDSMAN PROGRAM.

CHAPTERED LEGISLATION, MASTER PLAN FOR AGING AND A LITTLE BIT ABOUT CDA BUILDING BACK BETTER. NOW I WILL TURN IT OVER TO MARK BECKLEY.

>> GREAT THANK YOU SO MUCH, I AM REALLY HAPPY TO BE HERE WITH EVERYBODY TODAY. MY NAME IS MARK BECKLEY, AS MENTIONED I AM THE ACTING DIRECTOR FOR THE CALIFORNIA DEPARTMENT OF AGING.

I WANT TO START WITH THE NEXT SLIDE PLEASE. WITH SOME NOTICES ABOUT LEADERSHIP CHANGES AT THE DEPARTMENT. SO I AM VERY HAPPY TO ANNOUNCE THAT OUR FORMER DIRECTOR KIM MCCOY WADE HAS BEEN SELECTED TO ASSUME THE NEWLY CREATED POSITION OF GOVERNOR OFFICE SENIOR ADVISER ON AGING DISABILITY, AND ALZHEIMER'S SERVICES. IN THIS ROLE, WILL BE REPRESENTING THE VIEWS, NEEDS, AND OPPORTUNITIES FOR INDIVIDUALS WHO ARE OLDER, INDIVIDUALS WITH DISABILITIES AND INDIVIDUALS WITH ALZHEIMER'S.

AT THE GOVERNOR'S OFFICE LEVEL. WILL BE AN ENERGETIC AND EXPERIENCED ADVOCATE FOR OUR PROGRAMS. AND NOT ONLY WILL SHE BE WORKING WITH TRADITIONAL

AGING AND DISABILITY STAKEHOLDERS THAT SHE HAS ALWAYS WORKED WITH. BUT ALSO BE REACHING ACROSS THE OTHER AGENCIES AND DEPARTMENTS AS WELL.

SUCH AS HOUSING, TRANSPORTATION, EMPLOYMENT SERVICES.

SO, WE ARE FORTUNATE TO HAVE SERVE IN THE ROLE.

AND LOOK FORWARD TO CONTINUE TO WORK WITH HER IN THE NEW ROLE.

I AM ALSO PLEASED TO ANNOUNCE THE SELECTION OF THE NEXT CDA DIRECTOR, SUSAN, MANY OF YOU MAY ALREADY KNOW HER. SHE HAS WORKED AT THE ALZHEIMER'S ASSOCIATION AS THE SENIOR POLICY ADVISER ON ALZHEIMER'S ISSUES. SHE HAS ALSO PREVIOUSLY HELD POSITIONS AS A HEALTH POLICY ADVISER FOR THE LEGISLATURE AT UC DAVIS AND PREVIOUSLY WORKED FOR LEADING AGE OF CALIFORNIA.

SHE WAS ALSO IN MENTAL IN THE DEVELOPMENT OF THE MASTER PLAN FOR AGING, V SERVED ON THE LONG-TERM SERVICES AND SUPPORTS SUB COMMITTEE. WE ARE VERY EXCITED TO HAVE HER AS OUR NEXT LEADER.

SOMEBODY WITH GREAT DEPTH AND EXPERIENCE ABOUT AGING, DISABILITY AND ALZHEIMER'S ISSUES, SHE WILL BE STARTING WITH US IN NOVEMBER. ANOTHER KEY LATER, WE ARE ING INTO OUR DEPARTMENT AND HAVE BROUGHT IN. IS SUTEP, CDA'S NEW DEPUTY DIRECTOR FOR HOME AND COMMUNITY LIVING.

IN THIS ROLE, THEY OVER SEE OUR OLDER AMERICANS ACT PROGRAMS, TWO WAIVER PROGRAMS, MULTISENIOR SERVICES AS WELL AS Q AND A BASED ADULT SERVICES PROGRAMS. ADULT AND DISABILITY RESOURCE CENTERS. GLAD TO HAVE SOMEONE WITH THAT EXPERIENCE. PREVIOUSLY THE DIRECTOR OVER IHSS PUBLIC AUTHORITY IN SANTA CLAR, AND WORKED FOR THE BETTY MOOR FOUNDATION AT UNIVERSITY OF SAN FRANCISCO. AND VARIOUS HEALTH AND COMMUNITY BASED PROGRAMS.

HE STARTED WITH US IN AUGUST. OKAY. NOW I WANT TO TALK ABOUT SOME CURRENT RECRUITMENTS THAT WE HAVE FOR OTHER LEADERSHIP POSITIONS IN CDA. FIRST IS RECRUITMENT FOR THE STATE LONG TERM CARE OMBUDSMAN. ACTIVELY RECRUITING OVER THE LAST SEVERAL MONTHS AND HOPE TO SELECT A CANDIDATE ONCE SUSAN COMES ON BOARD AS THE NEW DIRECTOR IN NOVEMBER.

HOPE TO MAKE THAT SELECTION BEFORE THE END OF THE YEAR. WE ARE RECRUITING FOR A NEW CHIEF INFORMATION OFFICER. AS YOU MAY BE AWARE, CDA HAS A NUMBER OF DIFFERENT TECHNOLOGY INITIATIVES UNDERWAY. ONE KEY INITIATIVE THAT WE HAVE IS TO BRING ALL OF OUR DIFFERENT COMPUTER SYSTEMS UNDER ONE SINGLE COMPUTER SYSTEM PLATFORM FOR OUR LOCAL AREA AGENCIES ON AGING. THIS IS WHAT WE CALL OUR CLIENT RELATIONSHIP MANAGEMENT SYSTEM PROJECT.

WE ALSO PLAN TO BRING ALL OF OUR ADRC PROGRAMS UNDER THE SAME UMBRELLA. AND OUR FUTURE VISION IS REALLY CONSOLIDATE AS MANY OF THE PROGRAM SYSTEMS UNDER ONE UNIFIED PLATFORM TO REALLY GET A GOOD HOLISTIC ENTERPRISE AND PERSON-CENTERED VIEW OF ALL OF THE SERVICES WE OFFER TO THE AGING AND DISABILITY INDIVIDUALS WE SERVE THROUGH THE STATE.

WE ARE ALSO TVLY WORKING TO COLLECT LOSS OF DATA FROM DIFFERENT DATA SOURCES TO GET THAT HOLISTIC PERSPECTIVE ON HOW, AND HOW WELL WE ARE SERVING OLDER ADULTS AND INDIVIDUALS WITH DISABILITIES THROUGH THE STATE.

SO, IF YOU KNOW ANYBODY WHO WOULD GOOD FOR THIS POSITION, WE REALLY ENCOURAGE YOU TO HAVE THEM APPLY. ANOTHER KEY POSITION I WANT TO MENTION IS THE NEW POLICY DIRECTOR, THIS IS A POLICY DIRECTOR OVER POLICY RESEARCH AND EQUITY. THIS DEPUTY DIRECTOR POSITION, WILL REALLY FOCUS ON THOSE AREAS OF THE MASTER PLAN WHERE CDA HAS NOT TRADITIONALLY HAD A LOT OF INVOLVEMENT OR ACTIVE POSTURE.

AREAS OF HOUSING, HEALTH, EMPLOYMENT SERVICES AND EQUITY ISSUES, THIS POSITION WILL REALLY BRING UP THOSE ISSUES AND MAKE THEM A FOREFRONT OF ISSUES THAT AGING WILL INTERVENE WITH AND BE INVOLVED WITH GOING FORWARD. I ALSO WANT TO MENTION THIS POSITION WILL BE

A KEY COUNTERPART TO 'S POSITION AS PROGRAM
DEPUTY OVER THE OTHER PROGRAMS. TO SERVE ALL OF THE
PROGRAM CUSTOMERS.

AND THEN FINALLY I WANT TO MENTION THE NEW POSITION OF LONG TERM CARE PATIENT REPRESENTATIVE. THERE IS A COURT DECISION THAT CAME OUT LAST YEAR THAT FOUND THAT FACILITIES WHO OPERATE INTERDISCIPLINARY TEAMS THAT MAKE KEY HEALTH DECISIONS ABOUT RESIDENTS DID NOT HAVE ADEQUATE REPRESENTATION FOR THE PATIENTS ON THESE IDT BOARDS.

SO, THIS NEW PROGRAM WILL ENSURE THAT UNREPRESENTED INCAP ACETATED PATIENTS DO INDEED HAVE REPRESENTATION WHEN IT COMES TO HEALTH DECISIONS THAT AFFECT THEM. NEXT SLIDE, AND THEN I JUST WANT TO HIGHLIGHT KEY INITIATIVES THAT CDA WILL BE ACTIVELY ENGAGED IN FOR 2022. FIRST ONE IS WORKFORCE. A PROGRAM FUNDED WITH \$150 MILLION, THAT WILL BE FOCUSED ON DIRECT CARE WORKERS IN NONICE SETTINGS THAT CARE FOR OLDER ADULTS, INDIVIDUALS WITH DISABILITIES.

TO MAKE SURE THAT THOSE WHO ARE CURRENTLY ACTING AS CAREGIVERS ARE SUPPORT IN UPWARD DEVELOPMENT AND MOBILITY, TRAINING AND STIPENDS PROVIDED TO THE WORKERS TO MAKE SURE THEY CAN CONTINUE TO PROGRESS ALONG THE CURRENT PATHS.

ALSO THIS PROGRAM WILL ACT AS INCENTIVE TO ENCOURAGE

OTHERS TO JOIN THE DIRECT CARE WORKFORCE SO THEY CAN RECEIVE TRAINING AND STIPENDS FOR ENTERING THE WORKFORCE.

AS WE KNOW THERE IS A HUGE GAP IN DIRECT CARE WORKERS, STATEWIDE, HOPEFULLY THAT WILL HELP BRIDGE THE GAP. ANOTHER ONE IS ADULT FAMILY HOMES, SO, WHAT THIS INTENDS TO DO IS PLACE INDIVIDUALS WITH COGNITIVE IMPAIRMENTS IN THE HOMES OF FAMILIES WHO ARE WILLING TO ACT AS CAREGIVERS.

THE HOPE IS THAT ONCE THESE INDIVIDUALS BECOME MEMBERS OF THESE FAMILIES THEY ENJOY THE SOCIAL AND MENTAL HEALTH BENEFITS OF BEING PART OF FAMILY UNITS. THIS PROGRAM IS MODELLED AFTER THE SUCCESSFUL DEPARTMENT OF DEVELOPMENTAL SERVICES PROGRAM, FAMILY HOMES A

WE LOOK FORWARD TO THAT PROGRAM. NEXT IS SOMETHING I BELIEVE HEALTH AT HOME BRANCH CHIEF WILL SPEAK ABOUT MORE. ALZHEIMER'S DAY CENTERS, THIS IS A PROGRAM THAT DID RECEIVE FUNDING FROM THE STATE BACK IN 2009 AND 2010. DUE TO BUDGET CONCERNS AT THE TIME THE FUNDING WAS TAKEN BACK.

NOW BEING PARTIALLY RESTORED WITH \$5 MILLION. SO WHAT THE ADULT DAY CENTERS AND OUR STAKEHOLDERS PLAN ON DOING IS STANDING UP 5-8 PILOT SITES SO THAT THE EFFECTIVENESS OF TREATING PEOPLE WITH ALZHEIMER'S IN

THE COMMUNITIES WITH QUALITY SOCIAL PROGRAM AND HEALTH INTERVENTIONS WILL REALLY HELP INDIVIDUALS THAT HAVE ALZHEIMER'S.

THEN I WANT TO MENTION THE NUTRITION INFRASTRUCTURE PROGRAM. \$40 MILLION GENERAL FUND. AS WE KNOW NUTRITION PROVIDERS HAVE BEEN DOING A GREAT JOB IN TERMS OF SERVING MORE MEALS THAN EVER DURING THE COURSE OF THE PANDEMIC AND THIS FUNDING WILL ALLOW REFRESH OF THE KITCHEN EQUIPMENT AND REFRIGERATION UNITS AND INFRASTRUCTURE THEY NEED TO DO THE WORK THEY DO.

AND FINALLY THE DIGITAL DIVIDE, BUDGET INCLUDED 67
MILLION TO EXPAND THE STATE'S DIGITAL DIVIDE INITIATIVES
TO HELP OLDER ADULTS GET CONNECTED WITH TECHNOLOGY
AND GET CONNECTED WITH BROAD BAND SO THAT WE CAN SEE
BENEFITS IN DEUCING SOCIAL ISOLATION AND
INCREASING TELE HEALTH AND INFORMATION FROM THE
INTERNET.

17 MILLION WILL BE ALLOCATED TO TRADITIONAL PARTNERS, HCBS PARTNERS WE WORK WITH AND \$50 MILLION GOES TO COUNTIES TO DISTRIBUTE TO OLER ADULT RESIDENTS IN THE COUNTIES AS THEY SEE FIT.

OKAY, COVID-19, I REALLY WANT TO HIT UPON SEE CHANGES WITH COVID-19. AS WE KNOW, COVID-19 REMAINS ON THE THE FOREFRONT OF ALL OF OUR MINDS, AS WELL AS

CONTINUES TO BE ADMINISTRATION'S FOCUS. NEXT SLIDE, PLEASE. I WILL BRIEFLY SUMMARIZE SYSTEM OF THE KEY PUBLIC HEALTH ORDERS THAT HAVE COME OUT. THERE IS ORDERS THAT REQUIRE VACCINE VERIFICATION FOR STATE WORKERS, VACCINATIONS, OF COURSE FOR HEALTH CARE WORKERS, UNIVERSAL MASKING IN K-12 SETTINGS, MEDI-CAL INCENTIVE FOR VACCINATION, AND STATEWIDE MASK RECOMMENDATIONS.

SO, AGAIN ALL OF THESE PUBLIC HEALTH ORDERS HAVE THE PURPOSE AND INTENT OF KEEPING US SAFE, THOSE MOST VULNERABLE AMONG US, OLDER ADULTS AND INDIVIDUALS WITH DISABILITIES AND THOSE ARE IMMUNE COMPROMISED HEALTH SYSTEMS.

SO YOU KNOW ADMINISTRATION IS COMMITTED TO CONTINUE TO PUSH FORWARD THOSE POLICIES AND THOSE ORDERS THAT WILL CONTINUE TO PROTECT US AND KEEP US SAFE. NEXT SLIDE, PLEASE, OKAY, THIS IS A REMINDER, OF WHAT'S AT STAKE.

SO, IT'S REALLY IMPORTANT THAT WE KEEP THE PUSH, EDUCATION, OUTREACH, REQUIREMENTS WHEN IT COMES TO VACCINATIONS, BECAUSE WE KNOW THAT OLDER ADULTS CONTINUE TO BE A GREATEST RISK OF ADVERSE HEALTH OUTCOMES AND DEATH DUE TO COVID COMPLICATIONS. THIS IS REAL NUMBERS, WE KNOW WHAT'S AT STAKE, SO, WE HAVE TO KEEP PUSHING THE ISSUES FORWARD. NEXT SLIDE,

PLEASE.

OKAY, AND, AGAIN YOU KNOW, THIS IS THE SNAPSHOT OF VACCINATIONS BY AGE, THEY DO CONTINUE TO INCREASE STATEWIDE. THAT'S THE GOOD NEWS, HOWEVER AT THE SAME TIME WE KNOW THAT THERE IS A SIGNIFICANT NUMBER OF PEOPLE IN CALIFORNIA THAT ARE NOT VACCINATED AND WE HAVE TO REALLY PUT FORWARD TO BEST EFFORTS THROUGH ACTIVE EDUCATION AND OUTREACH AND SERVICES TO ENSURE THAT PEOPLE DO MAKE DECISIONS TO BECOME VACCINATED ADDITIONAL MONEY AS BEEN ALLOCATED TO AREA AGENCY ON AGING.

AS WELL AS THE AGING AND DISABILITY RESOURCES. TO ENSURE THAT WE CAN CONTINUE TO DRIVE AND PUSH FORWARD. NEXT SLIDE? AGAIN, I AM NOT BEGINNING TO GO OVER EVERYTHING, BUT, BASICALLY SAY, THAT AGAIN, YO KNOW, STATE ADMINISTRATION, FEDERAL ADMINISTRATION, CONTINUES TO BE COMMITTED TO ENSURING SAFETY FOR ALL YOU KNOW, UNITED STATES AND CALIFORNIA RESIDENTS AND THE PFIZER BOOSTERS ARE ONE WAY TO ADD THAT. WE EXPECT OF COURSE MDORNA AND J ANDJ BOOSTER SHOTS AVAILABLE AS WELL. WE LOOK FORWARD TO THAT, , RECENTLY HEARD THE ADMINISTRATION RELEASED ITS PLAN TO VACCINATE CHILDREN AGES 5-11, REALLY GOOD NEWS. NOW I WANT TO TURN OVER TO CONY TO TALK ABOUT THE EFFORTS WE ARE TAKING AT CDA AND COLLABORATION WITH CDPH TO

>> SO NOW, I WILL GET INTO IT REALLY QUICKLY A LITTLE BIT MORE ABOUT WHAT WE ARE DOING FOR THE VACCINE OUTREACH CAMPAIGN. AS MARK HAD INFORMED US WITH CDPH INDICATES THAT 82% OF OLDER I S 65 PLUS HAD ONE OR MORE DOSES.

18% LEFT WE ARE CONTINUALLY DOING OUTREACH FOR THEM TO GET INITIAL VACCINES AND NOW WITH THE BOOSTERS THAT IS ADDED MESSAGING TO ALL OLD ADULTS TO 65 PLUS AS WELL. STATEWIDE VACCINE OUTREACH CAMPAIGN CONTINUES WITH PAID MEDIA TACTICS.

HERE IS A BRIEF SNAPSHOT OF THE CREATIVES WE HAVE USED. YOU SEE FOR THE DIRECT MAIL PIECE WE HAVE THE THE CARD THAT WE HAVE DONE TWO DIRECT MAIL DROPS NOW TO SELECT ZIP CODES WE WORK WITH. CDA IDENTIFIED ZIP CODES THAT HAVE LOWER PERCENTAGE OF VACCINATION RATE, WITH HIGHER CONCENTRATION OF OLDER ADULTS.

LINKS TO SAMPLES WE HAVE WORKED WITH IN CREATING AND RADIO SLOTS AS WELL. WITH THE DIRECT MAIL PIECES WE HAVE OVERRUN QUANTITIES WE CAN MAKE AVAILABLE TO FOLKS THAT WANT TO REQUEST IT. IF YOU WANT TO REQUEST SOME PIECES TO EITHER PUT IN YOUR LOBBY AREA, OR IF THERE IS YOU KNOW AN EVENT YOU MAY BE ATTENDING OR

WANT TO MAIL PIECES OUT YOURSELF.

>> HELLO EVERYBODY I AM DEPUTY DIRECTOR FOR ADMINISTRATION HERE AT THE DEPARTMENT OF AGING. I AM QUICKLY GOING TO GIVE UPDATES ON THE VARIOUS DIFFERENT FEDERAL AND STATE BUDGET INVESTMENTS, NEXT SLIDE, PLEASE.

AS MARK MENTIONED EARLIER IN HIS COMMENTS ABOUT SOME OF OUR INITIATIVES, CDA HAS RECEIVED RECORD LEVELS OF NEW INVESTMENTS THIS YEAR.

BOTH AT THE STATE LEVEL BUT ALSO AT THE FEDERAL LEVEL

WHICH INCLUDES OUR COVID RELIEF FUNDING AND PROPOSED HOMF AND COMMUNITY BASED SERVICES SPENDING PLAN FUNDING THAT IS STILL UNDER REVIEW BY CMS. I WILL START OFF WITH MOST RESENT DISTRIBUTION OF FUNDING. WHICH IS INCLUDED IN OUR AREA PLAN AMENDMENT. AND THAT IS OUR OLDER AMERICANS ACT PROGRAMS, MAJORITY OF THEM ARE FUNDED TO LOCAL AREA AGENCIES ON AGING, THAT AMENDMENT WAS RELEASED TO OUR PARTNERS ON THE 18TH. INCLUDES CONSOLIDATEDED APPROPRIATIONS ACT. WHICH WAS OUR THIRD GROUPING OF COVID RELIEF FUNDS TO OUR PARTNERS AND ALSO INCLUDES TITLE 20 ELDER JUSTICE FUNDING, WHICH IS ALSO PART OF COVID RELIEF FUNDING. ADDITIONALLY WE ARE RELEASING FUNDS TIED TO THE CARES ACT TO FUND OUR OMBUDSMAN ROBOTIC PET PROJECT. THE NEXT ITEM UP IS OUR AREA PLAN AMENDMENT THREE. WHICH WE PLAN TO RELEASE NO THE FIRST QUARTER OF 2022. THAT WILL INCLUDE ADDITIONAL TITLE III FUNDS, OLDER AMERICANS ACT FUNDS AND TITLE SEVEN. AND VERSION TWO OF THE RESCUE ACT FUNDING. AGAIN OUR LARGEST AND MOST RECENT INFLUX OF COVID RELIEF FUNDS. AGAIN AS I TOUCHED ON WHEN I STARTED WE HAVE ALSO RECEIVED VARIOUS DIFFERENT INVESTMENTS AT THE STATE AND FEDERAL I FVFI.

MARK WENT THROUGH MOST OF THESE I WILL RUN THROUGH THEM AGAIN. HCBS SPENDING PLAN. INCLUDES FUNDING FOR THE INITIATIVE, ALZHEIMER'S DAY CARE, PILOT, AND NUTRITION INFRASTRUCTURE, AMONG OTHER THINGS, IN THE PLANNING FOR THE PROJECTS AND WORKING WITH THE PARTNERS AND STAKEHOLDERS ON DEVELOPMENT AND ROLL OUT WITH MORE INFORMATION TO COME. I WILL HAND IT OVER.

>> GOOD MORNING EVERYONE I AM CHIEF FOR THE OLDER AMERICANS ACT PROGRAMS. NEXT SLIDE, PLEASE. WE HAVE A COUPLE OF UPDATES FOR YOU. WE ALSO WOULD LIKE TO WELCOME OUR C 4A EXECUTIVE DIRECTOR MICHAEL COSTA. 16 MILLION HOME DELIVERED MEALS WERE DISTRIBUTED FROM JANUARY OF 2021 THROUGH JUNE OF 2021. WE ALSO WANT TO LET YOU KNOW THAT OUR CDA IS GOING THROUGH A TRANSITION AND GETTING A NEW DATA TOOL. SO, WE WILL BE ABLE TO PROVIDE UPDATES FOR JULY 2021 MEALS AND OTHER INFORMATION AT OUR NEXT STAKEHOLDER MEETING IN JANUARY.

OUR TEAM IS ALSO GOING TO BE COLLABORATING WITH OUR PARTNERS TO DELIVER A LOCAL NUTRITION SERVICE WITH FUNDING FROM SENIOR NUTRITION HOME AND TY MEALS.

SENIOR INFRASTRUCTURE, CALIFORNIA EXPANSION, AMERICAN RESCUE PLAN AND CONSOLIDATED APPROPRIATIONS ACT. NEXT SLIDE, PLEASE. THANK YOU. FRIENDSHIP LINE. THIS ACCREDITED 24 HOUR TOLL FREE EMOTIONAL SUPPORT LINE IS FOR PEOPLE OVER60 YEARS AND OLDER AND ADULTS WITH DISABILITIES. WE HAVE TAKEN OVER 24 THOUSAND CALLS FROM JUNE OF 2021 THROUGH AUGUST OF 2021. COLLECTIVELY, FROM APRIL OF 2020 THROUGH AUGUST 2021 WE HAVE RECEIVED OVER 139 CALLS. 39 THOUSAND CALLS. ANOTHER PIECE OF GOOD NEWS IS THE CONTRACT FOR THIS SERVICE HAS BEEN EXTENDED THROUGH OCTOBER OF 2022. NEXT SLIDE, PLEASE. FALL PREVENTION. OUR AAA NETWORK HAS SUPPORTED OVER 2 THOUSAND PARTICIPANTS SERVED FROM JULY OF 2020 THROUGH JUNE OF 2021. FALL PREVENTION SERVICES INCLUDE IN HOME ASSESSMENTS, HOME MODIFICATIONS, GRAB BARS, AND EDUCATION CLASSES AND MORE. ALSO INITIAL ANOTHER INVESTMENT OF \$10 MILLION, ONE TIME ONLY, SUPPORTED BY THE OLDER ADULTS RESILIENCE AND RECOVERY ACT. NEXT SLIDE. SENIOR COMMUNITY SERVICE EMPLOYMENT PROGRAM. ALSO KNOWN AS CSEP. ANOTHER INVESTMENT PENDING THE APPROVAL OF 17 MILLION ONE TIME ONLY FUNDS WHICH WILL HELP EXPAND SENIOR EMPLOYMENT OPPORTUNITIES INCREASING PARTICIPANT SLOTS AT CALIFORNIA'S MINIMUM WAGE THROUGH 2026.

THEY ALSO COMPLETED OVER 7 HUNDRED PRESENTATIONS
DURING THIS SAME TIME PERIOD. NEXT SLIDE.
AND NOW I WOULD LIKE TO TURN IT OVER TO MY

INVESTMENT FOR 2022-23 FISCAL YEAR.

WE ALSO HAVE ADDITIONAL ONE TIME INVESTMENT OF 9.4 MILLION FOR OLDER ADULT RESILIENCY AND RECOVERY ACTIVITIES, AND PENDING CMS APPROVAL ADDITIONAL ONE TIME INVESTMENT OF \$5 MILLION TOWARDS HOME AND COMMUNITY BASED SERVICES PROGRAMS.

I AM ALSO HAPPY TO ANNOUNCE THAT OUR ADRC NETWORK IS GROWING STATEWIDE. WE CURRENTLY HAVE 8 ADRCS AND 11 EMERGING AND 4 HAVE SUBMITTED INTEREST THIS MONTH ALONE. PARTNERSHIPS ARE ESTABLISHED AND DEVELOPING IN 24 COUNTIES, COVERING 43% OF THE STATE POPULATION, INCREASE SINCE THE THE LAST STAKEHOLDER MEETING.

AND THE LAST UPDATE FOR CBAS IS IN REGARDS TO
PROVIDERS AND PARTICIPANTS, WE ARE CONTINUING TO WORK
WITH PROVIDERS AND PARTICIPANTS TO TRANSITION TO IN
CENTER SERVICES BASED ON CONDITIONS IN REPRESENTED

TIES. CURRENTLY WE ARE HOLDING REGULAR
DISCUSSIONS AND BRAINSTORMING SESSIONS WITH SISTER
AGENCIES UNDER IN CALIFORNIA HEALTH AND HUMAN
SERVICES AGENCY UMBRELLA.

ON RETURNING TO FULL SERVICES IN SAFEST EFFICIENT
MANNER WITH THE CONSIDERATION OF NEEDS AND HEALTH
AND SAFETY OF PARTICIPANTS.

WE ARE COLLABORATING DIRECTLY WITH OUR PARTNERS AT THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH,

AND INCLUDES ELECTRONIC VISIT VERIFICATION, AS WELL AS PROGRAM LANGUAGE UPDATES, SOME UPDATES INCLUDED, ARE WHAT RELATES TO THE DEMONSTRATION WAIVER KNOWN AS CCI.

ADDITIONALLY ENCLOSED EXPANSION OF SERVICE AREA OF ESTABLISH MSSP SITE, AND DETAILS ON THE EVV IMPLEMENTATION TIME LINE.

WE ENCOURAGE YOU TO PROVIDE PUBLIC COMMENTS ON THE MSSP WAIVER AMENDMENT AND MAY BE SUBMITTED TO OUR

INCREASE IN PRELIMINARY REPORTS SHOW WE ARE UPWARD
OF 5640 VISITS AS OF JUNE 2021.

SO WE ARE CLOSE TO WHERE WE WERE PREPANDEMIC, THIS IS GOOD NEWS. NEXT SLIDE. HERE WE SEE REFERENCE TO THE PROGRAM MEMO. PROVIDED DIE DANCE TO OMBUDSMAN PROGRAMS RETURNING TO FULL INDOOR IN PERSON SERVICES. VACCINE REQUIREMENTS AND TESTING PROTOCOLS AND PROTECTIVE EQUIPMENT.

THIS WAS RELEASED ON SEPTEMBER 23, AND POSTED ON THE WEBSITE IN THE PROGRAM MEMO SECTION. LOOKING AT OUR

ALSO CAREGIVERS AND TRANSITION AGE YOUTH IN 80:20
SPLIT. SO, GOAL TWO, HEALTH REIMAGINED. THIS--SO THE
BILLS THAT ARE LISTED HERE ARE PART OF A PACKAGE THAT IS
REFERRED TO AS THE PROTECT PLAN. ORIGINALLY THERE
WERE 7 BILLS.

FIVE OF WHICH BECAME CHAPTERED. THE INTENT OF ALL OF THESE IS REFORM THE WAY THAT OUR FOR PROFIT NURSING HOME CHAINS OPERATE AND TO DO THINGS LIKE BRING MORE FINANCIAL TRANSPARENCY AND REPORTING REQUIREMENTS AND ACCOUNTABILITY. NEXT SLIDE. GOAL THREE, INCLUSION AND EQUITY, NOT ISOLATION. I WILL HIT A FEW HIGH POINTS WE ARE PARTICULARLY EXCITED ABOUT. AB 133, ASSEMBLY HEALTH COMMITTEE BILL. WORKING WITH DEPARTMENT OF PUBLIC HEALTH TO STAND UP FIVE DEMONSTRATION PROJECTS.

THAT WOULD PROVIDE CLINICAL AND NONCLINICAL SERVICES
TO OLDER ADULTS LIVING WITH HIV. AB 665, REQUIRES
RESIDENTIAL CARE FACILITIES THAT HAVE EXISTING INTERNET
ACCESS TO PROVIDE AN INTERNET ACCESS DEVICE.
SUCH AS COMPUTER OR SMART PHONE OR TABLET TO THE
RESIDENTS TO HAVE TEL OH, HEALTH OR CONNECT WITH
FAMILY AND YOU KNOW HELP TO PREVENT THAT SOCIAL
ISOLATION THAT IS SO PREVALENT WITHIN OUR LONG TERM

CARE FACILITIES. SB 129, BUDGET ACT OF 2021, PROVISION IN THERE THAT FUNDS A PROGRAM. THAT PROVIDES REPARATIONS FOR INDIVIDUALS THAT WERE INVOLUNTARILY STERILIZED IN WOMEN'S PRISONS.

BETWEEN 1909 AND 1979, REPARATIONS UP TO \$25 THOUSAND PER SURVIVOR. AND WE ARE WORKING TO SORT OF DEVELOP COMMUNICATIONS THAT YOU WILL PROBABLY SEE COMING OUT ON THE SOCIAL MEDIA CHANNELS IN THE NEAR FUTURE ON THIS BILL. FINALLY SB 258, LAYERED BILL THAT EXPANDS TO DEFINITION OF GREATEST SOCIAL NEED TO INCLUDE INDIVIDUALS LIVING WITH HIV.

SO, THE OLDER AMERICANS ACT STATUTE DIRECTS US TO TARGET OUR SERVICES TO INDIVIDUALS WITH THE GREATEST SOCIAL NEED. NEXT SLIDE, PLEASE. SO, GOAL NUMBER FOUR, CARE GIVING THAT WORKS, THIS BILL ALLOWS US TO USE SOME AMERICAN RESCUE PLAN DOLLARS TO STAND UP A NEW PROGRAM HERE AT DEPARTMENT OF AGING.

DIRECT CARE WORKFORCE TRAINING AND STIPENDS PROGRAM.
AND IDEA HERE IS THAT THIS WILL ALLOW NONIHSS WORKERS
TO INCREASE SKILLS AND JOB SATISFACTION AND JOB
RETENTION AS WELL AS SORT OF GIVE AN OPPORTUNITY TO
ADVANCE ON THE CAREER LATTER AND HOPEFULLY HIGHER
WAGES AS WELL. NEXT SLIDE, PLEASE.

NUMBER FIVE, AFFORDING AGING. SO THIS EXISTING LAW PERMITTED INDIVIDUALS WITH DISABILITIES TO BE PAID SUB

MINIMUM WAGE. AND THIS BILL PHASES OUT THAT. SO THAT IS NO LONGER YOU KNOW, INDIVIDUALS WITH DISABILITIES CAN NO LONGER BE PAID SUB MINIMUM WAGE. OKAY, NEXT SLIDE I BELIEVE THAT IS ALL OF MY SLIDES, AGAIN, ALL OF THESE BILLS I MENTIONS ARE ON THE WEBSITE. THANK YOU, I WILL HAND IT OVER.

BACK IN JUNE 2021. WE WILL PUT THE LINK IN THE CHAT IN A MOMENT. BUT THAT IS AVAILABLE ON THE MPA HOME PAGE. AS ADAM MENTIONED WE JUST SHARED SEVERAL LEGISLATIVE UPDATES, THAT DOCUMENT IS AVAILABLE ON CDA'S PAGE. REALLY EXCITING AS MARK MENTIONED, INITIATIVE NUMBER 99 IN GOAL THREE OF THE MASTER PLAN WAS TO APPOINT THAT SENIOR ADVISER ON AGING, DISABILITY, AND ALZHEIMER'S DISEASE TO REALLY ELEVATE AGING, AT THE GOVERNOR CABINET LEVEL. WE ARE VERY EXCITED TO HAVE KIM MCCOY WADE TAKING THAT ROLE. ALSO IN GOAL THREE, WE HAVE A FOCUS ON ELDER JUSTICE.

NEXT MONTH WE WILL BE ANNOUNCING THE NEW MEMBERSHIP
OF OUR ELDER AND DISABILITY JUSTICE COORDINATING

COUNCIL. VERY IMPORTANT TO INCLUDE THE DISABILITY IN THAT TITLE.

FIRST MEETING WE AIM TO HAVE THE BEGINNING OF DECEMBER. THIS COORDINATING BODY WILL ALIGN RESOURCES TO ADDRESS ELDER JUSTICE AS IN EXPLOITATION, ABUSE, WHETHER FINANCIAL, MENTAL, OR PHYSICAL AND OTHER FORMS OF NEGLECT AND ABUSE OF OLDER ADULTS AND PEOPLE WITH DISABILITIES.

NEXT SLIDE, PLEASE. SO, PARTNERSHIPS ARE KEY, OF COURSE, TO ADVANCING THE MASTER PLAN FOR AGING AND THOSE FIVE GOALS THAT ADAM JUST MENTIONED IN HIS REPORT. AND IT'S LY IMPORTANT THAT WE MAINTAIN RELATIONSHIPS AT THE LOCAL LEVEL. SO, WE DID CREATE A LOCAL PLAYBOOK FOR THE MASTER PLAN TO GUIDE LOCAL COMMUNITIES IN CREATING THEIR OWN AGE FRIENDLY PLANS. RECENTLY, I ALONG WITH FROM SAN DIEGO'S AGING AND ADULT SERVICES PRESENTED AT THE CALIFORNIA WELFARE DIRECTORS ASSOCIATION ON THE IMPORTANCE OF LOCAL AGE LY PLANNING.

I ALSO HAD THE PLEASURE OF ATTENDING EVENTS WITH SEVERAL COUNTIES INCLUDING THOSE IN INLAND EMPIRE. IN ORANGE, VENNTURA COUNTY AND BEYOND. WE HAVE BEEN ABLE TO PRESENT BEHAVIORAL HEALTH TASK FORCE ON THE IMPORTANCE OF OLDER ADULT MENTAL HEALTH. AFAR AS ACCOUNTABILITY AND OVERSIGHT, AS WE MENTIONED MANY

TIMES, THIS IS A TEN-YEAR VISION. NOT MEANT TO BE A PLAN THAT IS TO SIT ON A SHELF.

WE HAVE CREATED AN IMPACT STAKEHOLDER COMMITTEE THAT IS A COMMITTEE OF NINE INDIVIDUALS WITH STATE LEVEL LEADERSHIP TO PROVIDE ADVICE AND OVERSIGHT ON THE IMPLEMENTATION OF THE MASTER PLAN ACTIVITIES.

WE JUST MET THIS PAST WEEK, JUST A COUPLE DAYS AGO, ACTUALLY YESTERDAY. AND WE WILL MEET AGAIN IN JANUARY. THAT WILL BE TIMED WITH THE RELEASE OF THE ANNUAL MPA REPORT. WE ALSO HAVE DATA DASHBOARD FOR AGING, WE ARE CONTINUALLY ENHANCING, PROVIDING REFRESHED DATA AS WELL AS ADDING NEW INDICATORS. EXCHANGE OF INFORMATION BETWEEN AGENCIES AND INSTITUTIONS. WITHIN OF THOSE KEY FEATURES IS INTEROPERABLE INFORMATION. BEING ABLE TO SHARE AND BEING ABLE TO DO STREAMLINE REPORTING AND ALLOW OUR PARTNERS IN THE NETWORK TO REALLY ACCESS THAT INFORMATION AND BE ABLE TO DEMONSTRATE THE VALUE THAT WE ARE SERVING OUR POPULATIONS. JUST A LITTLE MORE ON THE PROJECT ACTIVITIES OF THE CRM EFFORT.

UPDATES, WE HAVE MOVED. CDA HAS MOVED TO THIS NEW ADDRESS, GATEWAY OAKS DRIVE. A COUPLE MINUTES AWAY FROM THE OLD CDA

- >> THANK YOU, MOVE BACK TO Q AND A, SOME ANSWERS ARE STILL BEING TYPED. QUESTION, WHAT ABOUT A BILL ADDRESSING ISOLATION, LIKE ESSENTIAL CAREGIVER ACT. ANYTHING IN THE LEGISLATION THAT WOULD RELATE TO THAT?
- >> THANK YOU FOR THE QUESTION, ONE BILL THAT SPECIFICALLY GETS AT SOCIAL ISOLATION, IS AB 665, IT'S A

CIA BILL. RCF'S THAT HAD INTERNET ACCESS ARE NOW REQUIRED TO PROVIDE DEVICES FOR THE RESIDENTS TO USE FOR THE PURPOSE OF COMBATTING THE EFFECTS OF SOCIAL ISOLATION.

I WOULD SAY GENERALLY WE COLLECTIVELY KNOW THAT
SOCIAL ISOLATION HAS TERRIBLE MENTAL AND PHYSICAL
EFFECTS ON INDIVIDUALS LIVING IN LONG TERM CARE
FACILITIES. I EXPECT TO SEE FUTURE BILLS ON THIS
TOPIC COMING OUT NEXT YEAR. THANK YOU.

>> I SAW A QUESTION IN THE CHAT ILY I WILL JUMP IN AND ANSWER. IF QUESTION WAS ARE THERE NEW MORTALITY STATISTICS POSTVACCINATION. I CAN'T FIND RAW STATISTICS ON THE CDPH WEBSITE. HOWEVER THERE IS DATA THAT COMPARES UNVACCINATED TO VACCINATED INDIVIDUALS THAT YOU KNOW DEMONSTRATED IN QUANTITATIVE TERMS. WE KNOW IF YOU ARE UNVACCINATED YO ARE MORE LIKELY TO CONTRACT COVID, TO BE HOSPITALIZED AND TO DIE. THAT DATA IS AVAILABLE, AND I WOULD ALSO MENTION ON THE CDC WEBSITE. THAT DATA IS ALSO AVAILABLE.

>> I AM INTERESTED IN FINDING OUT WHAT HAPPENED WITH REGARD TO NURSING HOME OVERSIGHT WITH REGARD

TO TRAINING STAFF ON PRINCIPLES AND PREVENTION OF CARRYING DISEASE FROM ONE CLIENT TO ANOTHER. GO AROUND TO THE CENTERS AND TRAIN STAFF, BUT BEEN DIFFICULTY IN TERMS OF FINDING PEOPLE WHO DO THIS JOB. THEY HAVE NOT BEEN ABLE TO HIRE ENOUGH NURSES. WHAT ARE INCENTIVES THEY ARE OFFERING TO PROSPECTIVE NURSE TRAVELERS WHO DO THIS AND IMPROVE THE COST OF TRAINING TO STAFF AND VARIOUS NURSING HOMES.

- >> THIS IS MARK, WHAT I CAN SAY TO THAT IS TRAINING OF NURSING HOME STAFF AND YOU KNOW INFECTION AND DISEASE ROLL AMONG NURSING HOMES DOES RESIDE IN THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH PER VIEW AS THE LICENSING AGENCY AND OVERSIGHT AGENCY FOR THE HOMES. WHAT I CAN SAY, I AM WELL AWARE THAT YOU KNOW, CDPH IN COLLABORATION WITH SEVERAL OTHER DEPARTMENTS AND FEDERAL PARTNERS ARE CONTINUING TO LOCK AT STRATEGIES TO IMPROVE INFECTION CONTROL AND INCREASE SAFETY, INCLUDING TRAINING.
- >> THANK YOU FOR ANSWERING. SO HERE IS A
  QUESTION, I THINK IT'S REFERRING TO UMM, YOU KNOW, WHAT
  CAN CDA DO OR CAN CDA DO ANYTHING FOR MORE RESOURCES
  OR BACKGROUND CHECKS. SOUNDS LIKE IT CURRENTLY IS
  TAKING FOUR WEEKS AT BEST TO HAVE A RESPONSE, WHICH IS

A LITTLE LONG. THE CURRENT PROCESSES ARE SLOW. IT'S SLOWING THE ABILITY TO HIRE AND PROVIDE SERVICES TO THE SENIORS AND COMMUNITY.

DO WE HAVE INSIGHTS OR RESPONSE TO THAT?

- >> SOUNDS LIKE BACKGROUNDS CHECKS FOR PUBLIC GUARDIANS. THE STATE DOES NOT HAVE ANY CURRENT OVERSIGHT RESPONSIBILITIES IN RELATION TO PUBLIC GUARDIANS, THOSE ARE COUNTY OPERATED PROGRAMS, IF THERE ARE BACKLOGS IN CHECKS FOR GUARDIANS, I WOULD CONTACT THE OFFICE IN YOUR AREA OR YOU KNOW COUNTY ADMINISTRATION. IF YOU ARE TALKING ABOUT BACKGROUND CHECK FOR OTHER TYPES OF STUFF. WE DO BACKGROUND CHECKS FOR STATE OMBUDSMAN. YOU KNOW. WE DO WORK COLLABORATIVELY WITH DSS TO HAVE THOSE COMPLETE. I WOULD SAY RIGHT NOW WE HAVE A GOOD WORKING RELATIONSHIP WITH DSS.
- >> GREAT, THANK YOU. SO LOOKS LIKE WE ARE RIGHT ON TIME. 10:59, WE WANT TO WRAP UP OUR STAKEHOLDER MEETING. IF YOU HAVE ADDITIONAL QUESTIONS, WE HAVE A FEW IN THE CHAT.
