RE: California Multipurpose Senior Services Program (CA-0141.R06.12) Amendment

Dear Director Baass:

The Centers for Medicare & Medicaid Services (CMS) is approving your request to amend the Multipurpose Senior Services Program for persons aged 65 or older. The CMS Control Number for the amendment is CA-0141.R06.12. Please use this number in future correspondence relevant to this waiver action.

With this amendment, the state is adding telehealth as a permanent service delivery option for specified waiver services, in compliance with California Welfare and Institutions Code section 14132.725, federal statute and regulations; and as agreed upon by the applicant, participant, legal representative and Medi-Cal provider. The state also revised the implementation date for the changes previously approved in the amendment CA.0141.R06.10; the implementation date for the new waiver service unit types were changed from July 1, 2023, to December 31, 2023, in the Attachment #1: Transition Plan. The implementation date for the two waiver service categories for Community Transition Services (Moving and Housing/Utility Set-up) to be combined into one Waiver Service category (Community Transition Services: Combined) was also changed from July 1, 2023, to December 31, 2023 in Appendix C. Lastly, waiver year five estimates in Appendix J were updated to reflect use of the new waiver service unit types for half of the year instead of the full year. The effective date of the amendment is November 12, 2023. The Appendix K amendment that included provisions incorporated via this amendment expires on November 11, 2023.

The waiver continues to be cost-neutral. The average per capita cost of waiver services estimates (Appendix J.1) have been approved.

This approval is subject to your agreement to serve no more individuals than the total number of unduplicated participants indicated in Appendix J.2 of the waiver. If the state wishes to serve more individuals or make any other alterations to this waiver, an amendment must be submitted for approval.

It is important to note that CMS approval of this waiver amendment solely addresses the state's compliance with the applicable Medicaid authorities. CMS approval does not address the state's independent and separate obligations under federal laws including, but not limited to, the Americans with Disabilities Act, Section 504 of the Rehabilitation Act, or the Supreme Court's Olmstead decision. CMS reminds the state that the state must have an approved spending plan in order to use the money realized from section 9817 of the American Rescue Plan (ARP). Approval of this action does not constitute approval of the state's spending plan.
